BYLAW NO. 27-11 LEDUC COUNTY

A BYLAW TO DEFINE PROPERTY TO BE NON-EXEMPT FROM TAXATION.

WHEREAS

pursuant to Section 362(2) of the Municipal Government Act, being Chapter M-26, Revised Statutes of Alberta, 2000, and amendments thereto, the County is authorized to make by bylaw, any property that is exempt from taxation under Section 362(1)(n)(iii), subject to taxation to any extent the Council considers appropriate.

NOW THEREFORE BE IT RESOLVED

that under the authority of the Municipal Government Act, the Council of Leduc County, in the Province of Alberta, does hereby make any properties owned by NAV Canada, or owned by the Crown in right of Alberta or Canada or by any municipality or by any other body that is exempt from taxation under Division 2 of Part 10 of the Municipal Government Act and held by NAV Canada, and used for the purpose of providing civil air navigation services and in particular, the property described in the following Roll #'s (the "Property") that is exempt from taxation under Section 362(1)(n)(iii) of the Municipal Government Act subject to taxation:
