Coordinator - Agricultural Services Nathanael Berg entered the council chamber at 10:05 a.m.

Presentation

Chair Belozer invited ALUS representative Western Canada Lead Rhonda King to deliver her presentation to the Agricultural Service Board.

Where Agriculture & Nature Meet presentation:

- Mission statement "...helps farmers and ranchers build nature-based solutions on their land to sustain agriculture and biodiversity for the benefit of communities and future generations." Particularly on marginal lands for wetland restoration and enhancement, riparian buffers, shelterbelts, afforestation and native prairie grass restoration
- Not-for-profit, community based participants meet agricultural producer eligibility criteria

- ALUS guiding principles: community-developed; farmer-delivered; science-based; market-driven; integrated: targeted; accountable; voluntary
- ALUS projects primarily focused on marginal lands: bank restoration; pollinator habitat; wetlands; wildlife habitat; tree planting; exclusion fencing
- New pilot project: enhanced grazing projects on the working land adaptive multi-paddock grazing
- Biodiversity and ecosystem services: water filtration; cleaner air; carbon capture; aquifer recharge;
 native habitat; nutrient cycling
- Biodiversity benefits: restored and constructed wetlands (drought and flood mitigation); restored tallgrass prairies; ecobuffers
- Since inception in 2006, has expanded to be active in 31 communities across six provinces, with 1103 farmer/rancher participants (as at March 2021)
- On a Canada-wide perspective, generally larger projects in Alberta (as estimated on benefitting acres)
- Innovation and technology: data tools to support decision making and delivery of projects
- Numerous research partners including University of Guelph (hydrological software), InnoTech Alberta (formerly Alberta Innovates), Alberta Agriculture, Forestry and Rural Development, University of Quebec
- Municipality coordination: public works/infrastructure, planning and development
- Support from various private foundations, corporate, in-kind
- Alberta represents highest numbers municipal promotion and producer buy-in and commitment
- Research with carbon capture: federal initiative in initial stages of gathering information to quantify
- Stormwater management: currently working with Parkland County on municipal drainage plans
- Grazing forward, adaptive multi-paddock grazing project
- Recently, \$700,000 approved for indigenous bison initiative through federal On-Farm Climate Action fund. Approval represented small part of a much larger application.

Beaver removal work has taken place and the Pest Control Officer continues to monitor for beaver activity and holding capacity downstream.

Agricultural Services department activity report

Wetaskiwin Seed & Grain Cooperative - discussion

A brief discussion took place regarding the March 17, 2022 presentation to the Agricultural Service Board by a delegation from the Wetaskiwin Seed and Grain Cooperative (WSGC). A letter is anticipated from the WSGC board outlining their request for Leduc County representation and possibly other supports.

City of Edmonton Mosquito Abatement Program

Manager – Agricultural Services Aaron Van Beers provided additional information pertaining to the City of Edmonton mosquito abatement program notification. A very limited area of Leduc County could be included within the proposed program area, with permission from property owners, for ground treatment for aquatic larval stages of nuisance mosquitoes.

024-2022 Board member Scobie – that the Agricultural Service Board direct administration to respond to the City of Edmonton granting permission to conduct their 2022 mosquito monitoring and control program activities on Leduc County owned, operated, or leased lands utilizing products containing *Bacillus thuringiensis israelensis (Bti)* only.

Spring drainage - verbal staff report

Manager – Agricultural Services Aaron Van Beers provided a verbal staff report with reference to drainage performance from the 2022 spring run-off:

- Buckinghorse: licensed channel clean out and the addition of road culverts in a problematic location has improved run-off flow and drainage performance over all
- Clearwater: clean out work performed at Highway 814 south of Airport Road in 2020 and 2021 has improved system drainage and, overall, has worked very well in 2022

AB.

- Hay Lakes and Cameron drainage district areas are working as intended, but snow and ice accumulations have been slower to thaw in the east area and run-off has been moderate
- Roadside mowing performed in the fall to clean out identified roadside ditch areas has facilitated spring flows

Director – Road Operations and Agricultural Services Garett Broadbent provided comments on the clean out in the roadside ditch in the area of Township Road 492 west of Range Road 243. The drainage improvements have worked well in 2022 and additional work to further build up the road is being considered to provide additional benefit.
