Order and roll call

The meeting was called to order at 10:00 a.m. on Monday, March 7, 2022, by Glenn Belozer as chair and board members Rick Smith, Kelly-Lynn Lewis, Kelly Vandenberghe, Larry Wanchuk, Ray Scobie, and public members-at-large Roy Eckert and Russell Kushinski present.

Agenda adoption

Public presentation

Wetaskiwin Seed Cleaning Plant

Wetaskiwin Seed and Grain Cooperative (WSGC) board members Curtis Henkelmann, Mitch Lokke and Aaron Hundeby were invited to speak to their presentation:

- Request for support is not intended to be competition for the Warburg Seed Cleaning Co-op but rather a request to find areas of collaboration that would benefit both seed cleaning plant cooperatives and area producers
- The low level of fusarium head blight in the area is an advantage for local seed growers and is identified as a potential area of agribusiness growth
- A number of Leduc County producers (estimated to be 430 of approximately 1700 plant customers) currently do business with the WSGC, partially due to the logistical convenience for producers east of Highway 60

Some areas of beneficial collaboration: producer crop and disease information sessions, promotion
of stationary seed cleaning plant cleaning and inspection services, identifying the benefits of a seed
cleaning cooperative as a neutral structure is a value to producers

In response to a board member inquiry regarding specifics around a request for support/resources, Mr. Henkelmann responded with a suggestion for Leduc County representation on the WSGC board with support for some of the business aspects such as policy development, guidance on health and safety directives, communication campaigns to promote seed cleaning plant cooperatives.

Director of Road Operations and Agricultural Services Garett Broadbent commented that while Leduc County does inspections on mobile seed cleaning plants entering the County, some mobile plants do not notify the County. Public messaging may be required to communicate that inspection of mobile seed cleaning plants is an important aspect of maintaining standards. Mr. Henkelmann noted that he understands that the County of Wetaskiwin is developing an information piece for one of their upcoming newsletters defining the differences with mobile and stationary seed cleaning plants. Mr. Lokke commented that crop insurance claim submissions request indication of whether a mobile or stationary seed cleaning plant was utilized.

Federal Climate Plan - fertilizer emission reduction target

Manager – Agricultural Services Aaron Van Beers presented a staff report on the topic of the federal government's Environment and Climate Change Canada plan and the statement that this plan would set "a national emission reduction target of 30% below 2020 levels from fertilizers . . . "

- Reference is made in the 2020 document A Healthy Environment and a Healthy Economy regarding a reduction target but it does not specify what targets the plan is intended to address
- On-Farm Climate Action Plan announced February 22, 2022 with \$182.7 million in funding to be
 utilized by a number of recipient organizations (including ALUS) to deliver programs in several areas
 for Canadian producers to help meet national emissions reduction targets

AB.

- To date nine letters of concerns have been sent to the Minister of Environment and Climate Change from municipalities which focused on two areas of concern: 1) consequences on effect to production 2) ambiguity of reduction target statement with a request for clarification
- Efficiency in fertilizer use is a well-accepted positive for producers and while there has yet to be clarity around what the actual reduction targets may be, many crop producers within Leduc County may not need to make significant changes to their current practices

Comments were invited from the crop producer members of the public in attendance and Mr. Henkelmann remarked that there likely is not broad awareness of the technologies already utilized by crop producers that are addressing fertilizer use efficiency. Mr. Lokke further offered the perspective of the value in an expression of interest in the agricultural industry being part of developing a plan for a reduction solution.
