

#### Agenda adoption

#### **Agricultural Services department activity report**

Agricultural Services department staff provided comments on department program activities and seasonal staff recruitment that took place during the January and February 2023 period:

- The non-potable water point facility was back in service as of mid-February following identification of a malfunction with the security control module. Replacement parts were acquired and installed by a technical contractor.
- Discover Leduc Region Updates to Agritourism and Local Food listings. Leduc Farm Stand, providing
  a retail outlet for Hahn Family Farm and other local producers, will be opening in April at Jar'd
  Mercantile.

- Farm to Table dinner 60 seats available, event includes pre-dinner bus tour.
- ALUS grant allocation for 2023 projects has been confirmed.
- Canada Agriculture Day awareness Targeted Grade 4 in terms of curriculum fit. Contacted all schools within the Black Gold and STAR Catholic Schools division areas. Activity sheet packages provided for 987 students at responding schools with 79% of schools participating overall. Surveys were provided to teachers for feedback.
- 2 Billion Trees initiative funding provided by Government of Canada; coordinated by Agroforesty & Woodlot Extension Society (AWES) for shelterbelt, eco-buffer, and reforestation projects.

#### 2023 Northwest Regional Agricultural Service Board conference host

Manager of Agricultural Services Aaron Van Beers presented the staff report regarding the 2023 Northwest Regional Agricultural Service Board (ASB) conference. Each year, one of the thirteen municipalities within the region takes a turn to host the regional ASB conference event. Leduc County last hosted the conference in 2010 and is on schedule to be the host of the regional conference in November 2023.

#### Crop insurance premium increases – verbal report

Manager of Agricultural Services Aaron Van Beers provided remarks on news media reports of an anticipated 60% increase to crop insurance premiums: A review of the budget and forecast numbers suggests potential premium increases over two years at an approximate 22% increase per year. The premium formula is based upon a number of contributing factors such as cropland production rates, commodity market values and recent payout history. The federal and provincial governments are contributors to overall premiums with producers paying 40% of the premium cost.

Board member Kushinski provided his analysis of the premium formula calculation reckoning that the increase for producers will be in the range of 12-22% per year over the two-year period and remarked that individual producer claim history is an additional factor in determining premium rates. There have been at least two very high payout years overall on the prairies.

#### Information items

Manager of Agricultural Services Aaron Van Beers provided comments about the Municipal District of Taber February 28, 2023 letter to the Minister of Health, Honourable Jean-Yves Duclos. The letter requests that the Government of Canada extend the implementation timeline on the re-evaluation decision to cancel the registration of insecticide Lambda-cyhalothrin for use in livestock feed. Lambda-cyhalothrin products, such as Matador, are used to control insect pests including flea beetles and grasshoppers in crops. In Canada, the product continues to be approved under label for use on food products for humans but has now been deemed unsafe to be used on grain that may be used for livestock feed.

United States (US) Environmental Protection Agency (EPA) review of the product has maintained registration for use on grain both for human and livestock use. This inconsistency will potentially restrict importation of US grain into Canada for livestock feed and would have significant impacts to southern Alberta feedlots when Canadian feed grains are in short supply. Alternative insecticides are available but Matador has been the best option in terms of safety and pre-harvest intervals. Grasshoppers tend to build up closer to harvest and the pre-harvest interval period following application is a critical crop management point.

Health Canada Pest Management Regulatory Agency (PMRA) utilizes data algorithms for decision-making. There is an abundance of data on the product that establishes safety for human food products, but little data for safety on livestock feed. It is felt that this data discrepancy has been a key factor leading to cancellation of the registration of Lambda-cyhalothrin for use on livestock feed grain. Health Canada PMRA and the US EPA have different guidelines and evaluation processes and it is not uncommon that approvals differ from one country to the other. The MD of Taber's well-written letter requests urgent consideration of an extension to allow more time for meaningful research on the Lambda-cyhalothrin product and clearly states the impact that this restriction would impose on Canadian agriculture.
