## **Agricultural Services department activity report**

Agricultural Services department staff provided comments on seasonal staff recruitment and department program activities for the December 2022 period:

- Issues at the Non-potable Water Point facility have been ongoing through December with a line break
  at the outlet and subsequent technical issues. It is hoped that the system installation contractor will
  have this resolved within the week
- The 2022 insect survey summary has been received from Alberta Agricultural and Irrigation: pea leaf
  weevil and wheat midge were present in the area; populations will continue to be monitored and
  information about these crop pests will be shared with local crop producers
- Farm to Table Family Box Locally sourced products for a charcuterie box order event coordinated by Parks and Recreation
- On Farm Climate Action Fund information session January 31, 2023 at Glen Park Community Hall

#### Cleanfarms pesticide container collection program transition plan

Manager of Agricultural Services Aaron Van Beers presented the staff report regarding the Cleanfarms transition plan for pesticide container collection sites shifting to an ag-retail model in Alberta. The Nisku collection site is scheduled for closure January 1, 2025 while the collection site located at the Leduc County Thorsby Public Works shop facility will remain available as a convenience for west area ag producers.
