- 2025 Potential Extension: Forage, Animal Handling-Health & Nutrition, Biodiversity, Water Management, Grazing, Funding Opportunities, Winter Feeding
- Support requested of Leduc County: funding, sharing events, and collaboration
- Farming Forward are currently working a webinar series with Leduc County regarding livestock handling
- A Certification of Appreciation for support last year was presented to Chair Belozer
- Question and discussion on drone spraying for larger acre farms
- Question and discussion on organizational structure of Farming Forward
- Question and discussion about Canada Thistle Rust Fungus, with Farming Forward indicating they are leading this program

Bill C-293 verbal report

- Bill C-293 Pandemic Prevention and Preparedness Act
- There may be a risk to agriculture due to vague language
- Concerns specifically with "Plans contents (I) (ii) after consultation with the Minister of Agriculture
 and Agri-Food, the Minister of Industry and provincial governments, provide for measures to
 regulate commercial activities that can contribute to pandemic risk, including industrial animal
 agriculture"
- Concerns specifically with "Plans contents (m) (ii) "include the following information, to be provided by the Minister of the Environment: a summary of the measures the Minister of the Environment intends to take to reduce the risk that the commercial wildlife trade in Canada and abroad will lead to a pandemic, including measures to regulate or phase out live animal markets"
- There is discussion of Agricultural Service Boards writing letters; some counties have already started sending in letters
