- ➤ Allocating \$5,000 for consulting services.
- Requesting a 2023 Leduc County contribution in the amount of \$49,510.

# **Presentation - Canadian Energy Museum**

Executive Director Justin Williams - Canadian Energy Museum provided an update and presented the 2023 request for funding as follows:

- Mission of the Canadian Energy Museum (CEM) is to focus on all forms of energy within Canada as well as the history of oil and gas.
- > Currently employ two summer students and three full-time staff members. We are also looking to grow our board with two new board members.
- > Expanded new programs for school groups and virtual tour groups, plus increased community events including a successful Halloween event.
- > For 2023, we are continuing to look for new grants, growing the number of visitors to the facility, organizing collection storage and continue with Board succession.
- > The biggest expense is salaries and utilities which keeps the museum running.
- ➤ Revenue was good in 2022 with over 3,500 visitors. The campground and guest shop exceeded our expectations in revenue.
- Request \$25,000 from Leduc County for 2023.

# Q3 2022 reporting, ending September 30, 2022

General Manager of Financial and Corporate Services Renee Klimosko provided an overview of the 2022 Q3 reporting for the period ending September 30, 2022 with directors of departments in attendance to answer questions related to their respective departments.

In response to questions, the following was provided:

- The local improvements debentures will reach completion within the next year or so.
- Enforcement participated in the Joint Rehearsal Tabletop exercise for the Pope visit. The mock court trials exercise was related to traffic enforcement ticketing as a result of the change in provincial e-ticketing.
- The Jubliee Park campground closed the long weekend of September while the Centennial Park campground closed at the end of September. It would be difficult to extend the season past September due to staffing issues.
- The completion of a new policy to guide the County's participation in the siting of new telecommunications towers has not been approved by Council but will be presented to the Municipal Policy Review Committee in 2023.
- The increase in inflation rate has not been estimated for the 2023 budget.
- There is a delay in some of the large equipment delivery.
- Line painting has been completed; Garett Broadbent will investigate the line painting to be done near Thorsby.
