5.c.2 Direct Control Permit D24-046 indoor storage and warehouse with office - Roll 6323240

Planner Ben Ansaldo presented a recommendation for approval of Direct Control Permit Application D24-046 for an indoor storage and warehouse, office and fascia sign located on Lot 15, Block 1, Plan 1821205, Pt. NW 30-50-24-W4.

Administration recommends that Direct Control Development Permit Application D24-046 be approved subject to the following conditions:

- Approval is granted based on the information provided by the applicant for the proposed accessory building with fascia sign and no other development.
- 2. The proposed development shall be located as shown on the site plan submitted by the applicant.
- 3. The hours of operation shall be 7:00 a.m. 5:00 p.m. Monday Friday.
- 4. All portions of the site being utilized for activity or vehicular movement that are not landscaped shall be paved and/or graveled to reduce dust generation.
- 5. Parking shall be provided in accordance with the provisions of the Leduc County Land Use Bylaw and as indicated in the attached approved site plan.
- 6. No outdoor storage of goods or materials is permitted on the subject property.
- 7. The site shall be maintained in a neat and orderly manner including the containment of all construction materials and refuse, to the satisfaction of the Development Authority.
- 8. No use or operation shall cause or create any significant impact or nuisance during normal operation which, in the opinion of the Development Authority, may be objectionable beyond the boundary of



the site which contains it, by way of but not limited to the following: odors; dust; noise; air pollution; industrial waste; and high brightness light source.

- 9. The development shall not cause any adverse drainage impact on adjacent properties or flooding of nearby ditches in excess of their capabilities.
- 10. All accesses required off of a Leduc County public roadway shall be constructed to the satisfaction of Leduc County Engineering Department.
- 11. The landowner shall provide firefighting access at all times to the satisfaction of the Leduc County Fires Services Department.
- 12. Prior to commencement of development, the landowner shall enter into a development agreement with Leduc County, and abide by the terms therein, addressing:
 - a. the connection to water and sewer infrastructure with a site servicing plan;
 - b. lot grading plan;
 - c. landscaping; and
 - d. remit a deposit in the amount of \$20,000 for a paved approach, to the satisfaction of Leduc County.
- 13. No further development, expansion or change in use is permitted unless approved by Leduc County Council.
