- requesting support for a project scoping study for the hospital emergency room renovation and the report is the essential first step in undertaking such a significant capital project;
- Alberta Health Services has estimated the study will cost up to \$35,000; are seeking partner funding to complete this study in 2024 with the cost split between the Foundation, the City of Leduc and Leduc County; and
- in addition to the \$2750 already committed by the County, an additional \$8950 is requested for this study.
