ASB bursary awards

Manager-Agricultural Services Aaron Van Beers reported that the 2020 Agricultural Service Board bursary awards deadline for submission of applications was November 20, 2020. This January 18, 2021 meeting is the first meeting of the Agricultural Service Board following the November 30, 2020 deadline. \$5000 was approved in the 2020 budget for five bursaries of \$1000 each. Four well-prepared and eligible applications were received for consideration.

2021 Provincial Agricultural Service Board conference resolutions

Manager-Agricultural Services Aaron Van Beers provided a report with respect to the resolutions that will be presented at the upcoming 2021 Provincial Agricultural Service Board conference and discussed clarifying points on each of the resolutions:

- 1-21 the agricultural community in Alberta has been burdened with the lack of regular oil lease maintenance where resource companies have become insolvent or are unresponsive to requests for weed management on lease sites. Request legislation and standards to protect landowners.
- 2-21 currently municipalities manage collection of pesticide containers for recycling in cooperation with CleanFARMS. Leduc County costs relate to maintaining the two facilities located at two sites on County property. Resolution proposes placing responsibility for collection on the agricultural retailers/dealers.
- 3-21 and 4-21 registration ending for use of 2% liquid strychnine for control of Richardson's ground squirrels: Extend/reinstate registration of 2% liquid strychnine for control of Richardson's ground squirrels until such time as another effective product is registered for use. Resolution 4-21 that producers with Farmer Pesticide Certificate be provided with the opportunity to purchase and use strychnine.
- 5-21 revise labeling requirement for "Fusarium free" seed so that the sample is taken at the seed plant after it is cleaned to provide a greater level of assurance to the buyer.
- 6-21 producers be provided with the option to allocate check-off dollars directly to local research and development organization or Agricultural Service Board of their choice.
- 7-21 ASB representation and technical advisor selected by the Alberta Association of Agricultural
 Fieldmen and representative chosen by the ASB Provincial Committee to be present during policy
 and legislative discussions at commodity group and agricultural associations annual general
 meetings or special meetings. Clarification will be required with regard to the extent of these
 meetings and types of policy discussions.
- 8-21 Alberta Agriculture + Forestry extension staff be reinstated to assist agricultural producers throughout Alberta.
- 9-21 Agriculture Canada and Canada Food Inspection Agency abandon proposal to implement a system to collect royalties on farm-saved seed.



• 10-21 - provide a farm fuel exemption for all consumption of propane and natural gas for ALL agricultural production practices including greenhouse, grain drying, and other similar practices.

Large culvert beaver screen options

Manager-Agricultural Services Aaron Van Beers provided a staff report pursuant to November 9, 2020 Agricultural Service Board motion 061-2020:

that with reference to beaver screens or gates to protect road culverts from beaver damming activities:

- 1) staff investigate various options for beaver screens or gates and the relative costs and maintenance requirements associated with those options, and further that
- 2) staff undertake an inventory of other road culverts of this approximate size that are currently subject to beaver caused obstructions.

Van Beers reported that he has discussed types of manufactured beaver screens with the Agricultural Services welder/fabricator and that he will look closely at the site and beveled culvert end with a view to the feasibility of developing an in-house built screen or barricade.
