Order and roll call

The meeting was called to order (via Zoom) at 10:00 a.m. on Monday, June 14, 2021 by Glenn Belozer as chair and board members Tanni Doblanko, Kelly-Lynn Lewis, Ray Scobie, Kelly Vandenberghe, Larry Wanchuk and public member-at-large and Russell Kushinski present. Board member Rick Smith joined the meeting after the call to order. Public member-at-large Roy Eckert was absent due to personal reasons.

Agenda adoption

022-2021 Board member Wanchuk – that the agenda for the June 14, 2021 Agricultural Service Board meeting be adopted as circulated.

Action items progress report

Manager - Agricultural Services Aaron Van Beers provided information about ongoing monitoring of the culvert at Airport Road east of Range Road 234 to ensure that it remains free-flowing and discussed beaver activity on private property downstream. Van Beers confirmed that a review of culvert screens and other options for maintaining flow at the culvert are all being investigated by staff.

024-2021 Board member Lewis- that the Agricultural Service Board accept as information the action items progress report.

Agricultural Services department activity report

Manager – Agricultural Services Aaron Van Beers provided a staff activity report for the March through May 2021 reporting period and supplied the following additional information:

- Seasonal staff have been performing brushing work in support of Road Operations when weather conditions are unfavourable for spraying activities.
- The Pest Control Officer was able to address a number of beaver dams remaining from last year that
 were submerged throughout the 2020 season but are now accessible due to drier conditions. Beavers
 are more concentrated in pond pockets versus the flooded circumstances of the previous year with
 beavers spread out over-land. There has been a significant population explosion of muskrats and while
 they do not create dams, their burrowing habits have created road slope issues in a number of places.

Alberta Agriculture and Forestry – Key contact verbal report

Alberta Agriculture and Forestry key contact Trevor Wallace provided a verbal report:

- Crop moisture conditions in central Alberta are better than most of the province
- Canadian Agricultural Partnership (CAP) announcement on June 11, 2021: streamlining grant
 process; nine programs have been condensed under three topic areas 1) Growth and Value-Added
 2) Farm Efficiency 3) Public Trust
- \$1 million in program funding for beekeepers to help with post-pandemic recovery
- Online survey for CAP: seeking engagement as part of the first phase of the Next Policy Framework
- Agricultural Service Boards Town Hall meeting with the Assistant Deputy Minister on June 15, 2021

2020 Agricultural Service Board program field visit report

Manager – Agricultural Services Aaron Van Beers presented his report with reference to the field visit by representatives from Alberta Agriculture and Forestry (AAF) to assess Leduc County's program delivery in relation to legislated duties and requirements. A field visit summary detailing recommendations has been provided to administration.

Van Beers indicated that only minor changes to some processes are required and with reference to seed cleaning plant inspection review procedure and sample selection protocols clarified that AAF prefers that seed sampling was done periodically throughout the year rather than samples collected only at the time of the plant inspections.

Director – Road Operations and Agricultural Garett Broadbent commented on the decrease in Agricultural Service Board grant funding from \$168,000 grant (sometimes more) in years past to \$123,000 at the current grant level.

Local Food

Local Food Coordinator Sharon Faye presented her report highlighting program activities to date in 2021. Faye responded to a board member inquiry about direct sales for local food producers remarking that producers are seeing an increase in online sales and the e-commerce webinar was hosted with this business tool in mind. The map on the Discover Leduc Region site includes farmers markets and will continue to expand with additional locations and business categories.

Sustainable Agriculture

Sustainable Agriculture Coordinator Kim Barkwell reviewed her report providing program highlights for the March through May 2021 period. With reference to the recent Canadian Agricultural Partnership programs announcement, Barkwell affirmed that a current Environmental Farm Plan will continue to be a requirement for grant applicants.

Clubroot of canola

Manager – Agricultural Services Aaron Van Beers reported that a total of eight notices restricting the growing of canola will be issued resulting from pathotype testing results received from the University of Alberta. Six fields have been identified to contain pathotypes to which there is currently no commercially available genetic resistance and two fields will receive notices due to severity of infestations.
