

Officer Nelson reported that the Humane Society no longer oversees animal protection. Edmonton Police Service (EPS) does 100% of the investigations in Edmonton. They have a prosecutor that they consult with to lay charges. EPS reached out to Officer Nelson to be their liaison in this region.

Officer Nelson reported that last fall he became an Incident Command System 300 instructor. He will be co-teaching the course with two veteran instructors in the last week of April 2021. This class will include key people from Leduc County along with some participants from neighboring partners.
