#### Public presentation - New Sarepta railway crossing

Kris Murch provided a presentation requesting crossing upgrades to the crossing in New Sarepta. Two weeks ago there was an accident and Mr. Murch was first on scene. He researched the process for upgrades and he will ask Leduc County to request a slow order from CN, and a letter to Transport Canada to install a crossing gate. This crossing has a sidewalk, so it is different than others in the area. He has spoken to Transport Canada who have indicated they must do an investigation following an incident. They have indicated that investigation will be delayed due to COVID. This crossing has been potentially be grandfathered not to meet current standards. Mr. Murch also noted that the crossing is not as wide as the road, and has a sidewalk. He also indicated that there is potentially a 50% grant available from Transport Canada, and although there are no guarantees, a request would need to be made by the County to qualify. Committee member Smith inquired about the addition of stop signs to the crossing. Mr. Kotb indicates that Engineering is doing a full analysis of the roadway and crossing. Mr. Mryglod explained the flashing lights are equivalent to the stop sign, and do require vehicles to stop. A stop sign would be redundant, and the lights are more effective. Committee member Doblanko requests administration to refer this back to the report issued a few years ago regarding crossings that should have upgrades. Mr. Mryglod provided a process explanation for action going forward. Projected costs could be \$350,000 - \$400,000 according to conversations with Transport Canada, and could be driven up to \$600,000 if the switching terminal is required to be relocated. There are two parallel processes underway, one with CN Rail and one with Transport Canada. Any upgrade to the signalization at this rail crossing, warranted or unwarranted, would require Council approval to allocate funds. Chair Vandenberghe inquired about the slow down order. Mr. Mryglod will follow up to find out the process to request the slow down order, and proceed accordingly. Mr. Murch indicates that the current speed is 45 miles per hour.
