Public presentation – Waste to energy presentation

Mark Parker, Morrison Hershfield, provided a slideshow presentation on the logistics and feasibility on a waste to energy (WTE) system.

- Primary goal is waste processing and volume reduction.
- Energy output: by-product of WTE and secondary to waste processing/reduction.
- Technologies offer different ways of releasing the energy in the waste
 - Conventional WTE systems
 - Essentially power plants using waste as fuel instead of natural gas, coal or wood.
 - Advanced WTE systems
 - Use heat to convert the energy in the waste into a gas that can be burned for power, or converted to fuel (for burning)
- Leduc and District Regional Waste Management Authority (LDRWMA) principles for WTE evaluation process:
 - o Processor to be responsible for marketing end product
 - Commercial scale size to be proven technology (99.9% fail to meet this)
 - o Cost per tonne for processing is feasible compared to current tipping rates.
- Challenges are scale and feedstock.
 - o Smaller landfills are not feasible at this time.
- Reviewed the myths associated to WTE followed by a summary.
