MINUTES OF THE REGULAR COUNTY COUNCIL MEETING, LEDUC COUNTY, HELD ON TUESDAY, SEPTEMBER 4, 2018 IN THE COUNCIL CHAMBER OF THE COUNTY CENTRE BUILDING, NISKU, ALBERTA.

<u>Public Hearing – Proposed Amendment to Leduc County Land Use Bylaw No. 7-08 – File LA18-005 – Direct Control (DC) and Agricultural (AG) Districting – SE 28-49-24-W4, Zobel </u>

Mayor Doblanko convened the Public Hearing at 2:00 p.m. with respect to the proposed amendments to the Leduc County Land Use Bylaw 7-08.

Mayor Doblanko called upon Administration staff to provide background information.

Mr. Greg McGovern, Planner 1, provided a staff report with respect to the proposed amendments to the Leduc County Land Use Bylaw 7-08 for the redistricting of Direct Control and Agricultural Districts, highlighting the following:

- > The applicant advises that the purpose of the proposed amendment is to reconfigure, and increase (by 1.3 ha) the boundaries of the existing Direct Control area to allow for the continuation of clay extraction activities. Following the completion of extraction activities, the area is proposed to be remediated and restored to farmable, agricultural land.
- ➤ The applicant submits that the reasons for requesting the realignment and slight expansion of the existing extraction area is to allow for the subject parcel to be aligned with the contours and drainage of the parcel to the immediate west, following an approval in 2016 to undertake extraction works on that parcel. It is advised that should approval be given to the realignment of the Direct Control district to include additional lands to the north, the lands would then require the extraction of approximately 30,000 cubic metres of clay. Following the extraction, it is advised that subsoil and topsoil stockpiles on the property would be used to cover the disturbed area and the property will then be reclaimed for agricultural use.
- ➤ The subject site is located within the SE 28-49-24-W4. The site is bordered by Highway 623 to the South and is immediately adjacent to Saunders Lake to the North and East. The site is located approximately 2.4 km east of municipal boundary of the City of Leduc and is located within the City of Leduc/Leduc County Intermunicipal Development Plan area.
- Existing structures on the subject parcel consist of a detached dwelling, detached garage and a barn that are located directly from Highway 623. A further dwelling and outbuilding are located within the wider quarter section, in a subdivided parcel under separate ownership, also located off of Highway 623.
- The north half of the property is densely vegetated and slopes steeply downwards towards the shore of Saunders Lake. The south half of the subject property is largely clear of trees and presents downward sloping terrain from northwest to southeast.
- ➤ The southern area of the western portion of the site is where existing clay extraction activities occur. Extraction activities commenced in the summer of 2015 following a redistricting approval by Council. The approved development permit allowing for extraction activities (D15-119) expired in June 2017.
- ➤ The subject property is located within Area H of the City of Leduc/Leduc County IDP area and is designated as Reserve and Referral Area. The general purpose of the Reserve and Referral Area is to address lands outside the Growth Scenario and 2044 time horizon for strategic planning and environmental planning purposes, and to provide for future consideration that may not be foreseen at the time of adoption.



- > The proposed Land Use Bylaw amendment application was advertised in accordance with the provisions of the Municipal Government Act (MGA). The application was also referred to adjacent landowners as well as to the County's internal departments and external stakeholders, which included the City of Leduc under the provisions of the Intermunicipal Development Plan. There had been no comments made in respect to the application.
- ➤ The proposed amendment seeks to redistrict 2.4 ha (5.9 ac) area from the Agricultural (AG) District to the Direct Control (DC) District to allow for clay extraction, and to redistrict 1.1 ha (2.7 ac) from the Direct Control (DC) District to the Agricultural (AG) District. The remainder of the existing Direct Control area (as approved in 2015) is expected to remain.
- The existing clay extraction area abuts the property line separating the applicant's property from the neighbor to the west, where extraction activities also occur. Development Permit D15-119 was issued for a temporary two year period on June 2, 2015 to allow for Natural Resource Extraction in the area identified on the existing approved site plan.
- ➤ In 2016 Leduc County was alerted to the fact that the applicant/landowner had expanded the clay extraction area beyond the boundaries of the approved Direct Control District. The applicant was notified of the permit violation and he subsequently ceased the extraction activity in the unauthorized area.
- ➤ The proposed redistricting application is intended to allow for the completion of extraction activities and the subsequent restoration of the lands to farmland for agricultural activities. The redistricting plan presents a new boundary configuration for the Direct Control District that expands its boundaries [by approximately 2.4 ha (5.9 ac)] and realigns its location to the north to fully encompass the existing extraction area. This application would also put an area of unaltered land of approximately 1.1 ha (2.7 ac) on the south end of the current Direct Control District back to the Agricultural District.
- According to the applicant, should Council support the redistricting application, it would allow the subject area to be extracted of clay, and remediated back into agricultural use whilst aligning the site gradient to that of the lands to the west. It is proposed that the newly proposed Direct Control area would require approximately 30,000 cubic metres of clay to be removed in order to achieve the desired results. Should the redistricting be approved, development permits would first be required before extraction works could commence. At the development permit application stage, details such as final grading, extraction limits, timelines and operation hours would be addressed and appropriately conditioned under any approvals.
- In summary, the proposed amendment is required in order to allow the applicant the opportunity to gain the required development permits to resume extraction activities, finalize the project and return the lands to agricultural use. As a result of this, administration supports the proposal and recommends that Council gives first, second and third readings to the proposed Land Use Bylaw amendment.

Mayor Doblanko asked Council Members if they had any questions for Administration.

In response to questions by Council Members, the following information was provided:

- Clarification was provided with respect to the area of redistricting.
- > Any extraction application requires direct control districting.
- > The 2.7 acres proposed to return to agricultural have been untouched.

Mayor Doblanko called upon the applicant to speak to the proposed amendments.

Mr. Chris Zobel, applicant, provided the following comments:

- The reason for this request is to be in compliance with what has occurred.
- > Top soil has been piled on the outside area.
- Sales of the clay will occur and expect to have completion within two years.



- Operation of the site has occurred since 2015.
- There was one dust control complaint received which was taken care of by placing water on the roadway.
- > The land to be returned to agricultural is a hay field planted as alfalfa.
- Reclamation will occur as it proceeds.

Mayor Doblanko asked if there were any further correspondence, and there were none.

Mayor Doblanko called upon anyone in attendance to speak to the proposed amendments to Leduc County Land Use Bylaw 7-08.

Mr. Shayne Schultz, adjacent neighbour residing at 24358 Hwy 623, spoke in favour of the rezoning as the purpose is to bring the field down and reclaim back to agriculture.

Mayor Doblanko asked if there were any further questions by Council Members for clarification, and there were none.

Mayor Doblanko asked if there were any final comments by administrative staff, and there were none.

Bylaw No. 25-18 - Amendment to Leduc County Land Use Bylaw No. 7-08 - File LA18-005 - Direct Control (DC) and Agricultural (AG) Districting - SE 28-49-24-W4, Zobel
