#### Order and Roll Call

Trisha MacNeill, supporter of the Adorado Nino Horse Rescue, provided a presentation stating that Leduc County is lacking enforcement with Bylaw No. 14-14 (safe possession, sale, storage, purchase and discharge of low-hazard fireworks) and is causing safety issues within the County and is putting lives at risk as a result.

Ms. MacNeill submitted a written copy of concerns with respect to people and animal's lives being put at risk, including a horse that was injured as a consequence of a recent private fireworks display on the last August long weekend.

Ms. MacNeill requested a response from Council as to the timelines and what will be done for enforcement.

Mayor Doblanko advised that administration will review these comments, investigate and set up appropriate meetings with those involved and report back to Council at a future Council meeting.
