<u>Public Hearing – Removal of Municipal Reserve Designation Lot 6, Block 3, Plan 1277 HW, Pt. SE 26-50-25-W4</u>

Mayor Doblanko convened the Public Hearing at 1:45 p.m. with respect to the proposed removal of municipal reserve designation at Lot 6, Block 3, Plan 1277 HW, Pt. SE 26-50-25-W4.

Mayor Doblanko called upon Administration staff to provide background information.

Rick Thomas, Deputy County Manager, provided a staff report with respect to the removal of municipal reserve designation on Lot 6, Block 3, Plan 1277 HW, Pt. SE 26-50-25-W4, highlighting the following:

- 1) At the May 7, 2019 regular council meeting, Council approved Motion 135-19 directing administration to negotiate a lease agreement for the municipal parcel as described above for a period of five years with an option to purchase.
- 2) Brownlee LLP has been working on a lease agreement and option to purchase with Mr. Shield's legal representative and has suggested to remove the "Public Works Reserve" designation so the parcel can be leased and/or sold.
- 3) Administration has taken the necessary steps to advertise this public hearing which occurred in the September 20th and 27th, 2019 editions of the Leduc Representative.
- 4) There were no submissions received.

Removal of Municipal Reserve Designation Lot 6, Block 3, Plan 1277 HW, Pt. SE 26-50-25-W4

328-19 Councillor Lewis – that Leduc County Council directs the County Manager to notify the Registrar that the provisions of Division 9 of the Municipal Government Act have been complied with (Public Hearing and advertising) and Council wishes to remove the Municipal Reserve (Public Works Reserve) designation located on Lot 6, Block 3, Plan 1277 HW, Pt. SE 26-50-25-W4.

Public Hearing — Proposed Amendment to Leduc County Land Use Bylaw No. 7-08 — Redistrict from Direct Control (DC-011) District to Industrial District (IND) LA19-007 — Lot 1, Block 2, Plan 1124833, Pt. NW 7-50-24-W4 (LA19-007), Invistec Consulting Ltd./1620628 Alberta Ltd.

Mayor Doblanko convened the Public Hearing at 2:00 p.m. with respect to the proposed amendment to Leduc County Land Use Bylaw No. 7-08.

Mayor Doblanko called upon Administration staff to provide background information.

Colin Richards, Team Lead Development, provided a staff report with respect to the proposed amendment to Leduc County Land Use Bylaw No. 7-08, highlighting the following:

- 1) The applicant, Invistec Consulting Ltd. / 1620628 Alberta Ltd., submitted an application to amend the Leduc County Land Use Bylaw 7-08 to redistrict ±15.69 ha (±38.77 ac) on Lot 1, Block 2, Plan 1124833, Pt. NW 7-50-24-W4 from Direct Control (DC-011) District to the Industrial (IND) District. The purpose of the application is to align the property with the intended land use designation of the Northwest Saunders Lake Area Structure Plan.
- The proposed amendment was referred in accordance with the provisions of the Municipal Government Act and City of Leduc/Leduc County Intermunicipal Development Plan. The County received no concerns related to this amendment. The City of Leduc responded back that the proposal is compliant with the City of Leduc/Leduc County Intermunicipal Development Plan and NW Saunders Lake ASP.
- 3) Advertisement of the proposed amendment and public hearing occurred in the Leduc Representative as well as the Leduc County website in accordance with the provisions of



the Municipal Government Act. The proposal was also referred to adjacent municipalities and internal and external departments and agencies.

Alberta Health Services responded back that the district will allow the existing business to continue operations on a permanent basis. The industrial uses are allowed provided there are no off site impacts to which the applicant has confirmed. Alberta Health Services has no records of contaminated sites or landfills associated with this property and has no objections.

4) Planning and Development recommend that Council support the proposed redistricting from the Direct Control (DC-011) District to the Industrial District (IND) with the addition of a regulation applied to the subject parcel to prohibit uses within the area that are incompatible with the intended character of the plan area.

Kaylyn Stark, representing the landowner, Invistec Consulting, provided the following:

- > 1620628 Alberta Ltd. (Phoenix Industrial) is the landowner of subject property.
- > Are in support of staff recommendations.
- > Phoenix has operated on lands for 10 years and have had no negative impacts on adjacent properties.
- > This amendment would allow Phoenix Industrial to continue the existing land use.

Mayor Doblanko called upon anyone else to speak to the proposed amendment, and there was no one.

Mayor Doblanko asked if there were any further questions, and there were none.

- h) Notwithstanding the above, located at Lot 1, Block 2, Plan 1124833, NW 7-50-24-W4 the following uses shall be prohibited within the subject parcel as they are incompatible with the intended character of the plan area:
 - Abattoirs
 - Frame and fabric structures
 - Heavy industrial developments including but not limited to:
 - o Pulp and paper mills
 - o Asphalt or gravel crushing plants
 - o Oil refineries
 - o Outdoor storage associated with a principal use
 - o Pipe yards, wrecking and salvage yards
