### <u>Public Hearing – Amend Leduc County Land Use Bylaw No. 7-08 – Regulating Cannabis</u> Uses – Rural Centre Mixed (RCM) District

Deputy Mayor Lewis convened the Public Hearing at 2:01 p.m. with respect to the proposed amendment to the Leduc County Land Use Bylaw 7-08 – regulating cannabis uses within the Rural Centre Mixed (RCM) district.

Deputy Mayor Lewis called upon Administration staff to provide background information.

Mr. Colin Richards, Team Lead Development, provided a staff report with respect to the proposed amendment to the Leduc County Land Use Bylaw 7-08 to move the land uses Cannabis Accessory Store and Cannabis Retail Store from "Permitted Uses" within the Rural Centre Mixed (RCM) District, highlighting the following:

- On September 4, 2018, Council adopted Bylaw No. 22-18 which introduced Cannabis related land uses and governing regulations into the Land Use Bylaw 7-08 in order to respond to the federal legalization of recreation Cannabis.
- Within that bylaw, the uses Cannabis Accessory Store and Cannabis Retail Store were placed into appropriate districts as either permitted or discretionary uses, with the intent of aligning these use types with existing alcohol-based uses such as drinking establishment and liquor sales.



- ➤ A review of the regulations of the Rural Centre Mixed (RCM) District has recently been undertaken and where the uses Cannabis Accessory Store and Cannabis Retail Store were adopted as a permitted use, it is apparent that their placement as a discretionary use would be more appropriate within this district. This amendment would align Cannabis uses with alcohol-related uses within the district, rather than aligning them with residential uses. In order to achieve this, a Land Use Bylaw amendment has been proposed by the Planning & Development department that would relocate these uses from the permitted uses section, and place them in the discretionary uses section of the RCM District.
- ➤ The proposed amendment was referred in accordance with the provisions of the Municipal Government Act and advertised in the local newspapers. There has been one letter dated January 30, 2019 received from Alberta Health Services in support of the proposed amendment.

Deputy Mayor Lewis called upon anyone wishing to speak to the proposed amendment, and there was no one.

Deputy Mayor Lewis asked if there were any further questions by Council Members for clarification, and there were none.
