MINUTES OF THE REGULAR COUNTY COUNCIL MEETING, LEDUC COUNTY, HELD ON TUESDAY, MAY 26, 2020 IN THE COUNCIL CHAMBER OF THE COUNTY CENTRE BUILDING, NISKU, ALBERTA.

Order and Roll Call

<u>Public Hearing - Proposed Amendment to Leduc County Land Use Bylaw No. 7-08 – Add Cannabis Production Facility to North Saskatchewan River Valley (NSRV) District, C. Zobel TA20-002</u>

Mayor Doblanko convened the public hearing at 1:49 p.m. with respect to the proposed amendment to Leduc County Land Use Bylaw No. 7-08.

Mayor Doblanko confirmed the following in attendance via teleconference:

- Colin Richards, Team Lead Development
- Chris Zobel, Applicant

Mayor Doblanko called upon administration staff to provide background information.

Greg McGovern, Planner 1, provided a staff report with respect to the proposed amendment to Leduc County Land Use Bylaw No. 7-08, highlighting the following:

- 1) The applicant, Christian Zobel, applied to amend the Leduc County Land Use Bylaw 7-08 to allow for the cannabis production facility land use type as a discretionary use within the North Saskatchewan River Valley (NSRV) district. The applicant envisions that should council support the amendment, a development permit application would be submitted to consider the use on a +41.3 ha (+102.07 ac) parcel in the NSRV district.
- 2) Advertisement of the proposed amendment and public hearing occurred in the May 1st and 8th, 2020 editions of the Leduc Rep as well as the Leduc County website in accordance with the Municipal Government Act. The proposal was also referred to adjacent municipalities, and to internal and external departments and agencies.

Comments were received from Strathcona County, Camrose County and the City of Beaumont and all have no concerns with the proposed amendment. Parkland County similarly has no concerns so long as future development applications for large-scale cannabis production facilities within the NSRV district are referred to Parkland County during the application review stage.

Alberta Health Services commented and observed that the NSRV district does not contain any major population centres which make it easier to avoid off site impact to sensitive land uses such as schools, child care facilities and hospitals.



- Leduc County Public Works & Engineering also has no concerns with the proposed text amendment but points out that servicing requirements may be difficult to meet given the high water demand associated with cannabis production.
- 3) The proposed amendment will allow for development permit applications to be considered for cannabis production facilities. Planning & Development consider this use to be an appropriate discretionary use and recommend that council give first, second and third readings to the proposed amendment.

Mayor Doblanko asked if council members had any questions for administration.

In response to question by council members, the following information was provided:

- Clarification was provided with the definition between small scale and large scale.
- The proposed amendment does not affect the River Valley Alliance area.
- The requirement for a potential agricultural impact assessment would be considered by the development authority at time of application.
- The potential of limiting this redistricting application to a specific area was not presented to the applicant. To allow a site specific amendment would require a new process including re-advertising and referral to adjacent landowners.

Staff members Wice and Burnand

Director of Finance Natasha Wice and Manager of Assessment Services Karen Burnand entered the council chamber at 2:11 p.m.

Mayor Doblanko asked if there was any other correspondence received, and there was none.

Mayor Doblanko called upon the applicant to speak to the proposed amendment.

Chris Zobel, applicant, advised of the following:

- > Applied for a micro-operation in accordance with the Canada Health Act; there are limits to 200 sq. m.
- > The proposed operation will be on an outdoor tennis court which will be covered (hoop covering).
- > The cannabis will be grown in bags so can easily be picked up and moved.
- > Processing will be done within a 40 sq.m shed.
- > This is a very small restrictive operation and requires approval to be in compliance with the law.

Mayor Doblanko confirmed there were no registered speakers to the proposed amendment.

Mayor Doblanko asked if there were any further questions by council members.

In response to question by a council member, Mr. McGovern advised the development permit application would be reviewed by the applicable departments i.e. Public Works & Engineering for road use.

Mayor Doblanko called upon the applicant, Mr. Zobel, to provide closing comments and there were none.
