Potato Growers of Alberta – Presentation

Mr. Thomas McDade, Agricultural Director, Potato Growers of Alberta; Mr. Russell Van Boom, Board of Directors Chair, Potato Growers of Alberta; and Dr. Mike Harding, Research Scientist, Plant Pathology, Alberta Agriculture and Forestry were introduced to the Board.

Mr. McDade provided comments on the Potato Growers of Alberta (PGA) presentation "A Proud Alberta Success Story":

- 1899 first recorded commercial potato crop in Alberta
- 155 grower members in Alberta
- Currently over 50,000 acres in production, both seed and fresh/processing potatoes
- Farm gate value over \$250 million
- Economic value over \$1 billion in Alberta
- 80% of process production is exported
- Over 50% of the seed production is exported representing over \$20 million annually to growers
- Production follows a strict 1 in 4 year rotation with a rigorous phytosanitary program as directed by Canadian Food Inspection Agency
- · Seeding and harvesting equipment is routinely washed
- High tillage is a fact of potato production in Alberta

Board Member comments and PGA delegation responses were heard:

- Concerns with the tillage activities necessary for potato production on cropland under notice for clubroot. PGA representative response: As discussed in potato producer meeting, growers would not plan to go into potatoes on noticed land. Suggest amending existing clubroot policy to specify heavy tillage i.e. rototill.
- What are the concerns of the PGA regarding specifying potatoes in the clubroot policy? PGA representative response: The potato industry is small, visible, and relies heavily on export. The wording of the clubroot policy could be perceived to suggest that potatoes, themselves, are a negative impact.
- Concerns with soil tag on potatoes. PGA representative response: Potato seed growers have encountered this concern and some seed producers do not have canola in their rotation at any time. Dr. Harding commented that any soil movement presents a risk of carrying diseases, including clubroot. Mr. Van Beers commented that concerns with the potential to spread clubroot spores is with tillage activities, regardless of crop, but that intensive tillage is almost always carried out in potato production practices.

Municipal Policy - Agricultural Services Department - Verbal Report

Mr. Broadbent, Director of Agricultural Services reported that Agricultural Services administration undertook a thorough policy review when Agricultural Services department Municipal Policies were reformatted to standard one year ago. A policy review schedule was developed at that time. All policies are currently in the process of being updated to the new format and will be reviewed at an upcoming Municipal Policy Review Committee meeting before the end of 2018.

Mr. Broadbent, Director of Agricultural Services reviewed the action items progress report:

- Administration will endeavor to coordinate a more thorough ditch garbage cleanup along County main roads prior to the start of the mowing season in 2019 and review outcomes following that.
- With reference to the drainage complaint on SW 11-49-01-W5, administration met again with complainant and the neighbouring property owner. Provided information about the Small Drainage program guidelines and urged consideration of approaching the complainant's concern in this manner, if agreeable to the neighbouring property owner.

Agricultural Services Department Activity Report

Mr. Broadbent, Director of Agricultural Services indicated that the department activity report covers the majority of the growing season program period of June, July, and

August. Agricultural Services administration provided the following comments in relation to the reporting for the period:

- Rural roadside mowing trial Approximately 5,165 acres were mowed; the dry conditions yielded few rained out days and quicker passes with some second mowing passes in some places.
- Weed/brush control Coordination of spraying activities to support Public Works road operations for shoulder pull activities.
- Pest Control Review of process to meet requirements to remove beaver dams including clearances through Alberta One-Call and precautions to minimize risk to the public in the immediate area of blasting activities.
- Municipalities and Wetlands Management course Designed by Ducks Unlimited with support of the Government of Alberta; a full day course designed to help municipalities understand their role and resources available in the implementation of the Alberta Wetland Policy.
- Local Food and Agricultural Innovation will be a new activity report item Have approached Alberta Farm Fresh Producers Association to promote holding their annual conference in Nisku. Partnering with Leduc County and the Leduc Regional Chamber of Commerce would support common goals.
- Discussion took place on the topic of ground water.

Alberta Agriculture & Forestry - Key Contact Verbal Report

Alberta Agriculture and Forestry Key Contact, Mr. Trevor Wallace, Nutrient Management Specialist recapped a few of the projects he has been working on, including:

- Health Canada proposed ban on two neonicotinoid pesticides in a three-year phase out plan.
- Social media attention to glyphosate and the food industry.

Growing Forward 2 Producer Environmental Report

Mrs. Barkwell, Sustainable Agriculture Program Manager presented her report regarding Growing Forward 2 (GF2) aggregate data for Leduc County and County of Wetaskiwin showing projects and funds paid to producers. Dollar figures represents only GF2 funding percentage.

063-2018 Board Member Kushinski – that the September 4, 2018 report regarding Growing Forward 2 producer environmental programs be received as information.

Rural Roads Mowing Program Status Report

Mr. deMilliano, Agricultural Foreman presented his status report regarding the Rural Roadside Mowing program trial:

- Key Performance Indicators reveal that more mowing was achieved than was forecast owing to favourable mowing weather conditions and the efficiency of the mowing operator.
- Feedback from completed surveys was generally positive.
- Board Members reported on the comments received from residents with those comments varying from "not necessary", "cut too high", "needed in some areas, but not others", "good management of sweet clover". Additional Board Member remarks were heard:
 - o If no rural roadside mowing was done in the next growing season, there will be requests for it.
 - Concerns about timing if only one unit is covering the entire County and strategy development to optimize roadside mower time and mileage.
- Only 10 hours of down time was experienced due to non-routine repairs which speaks to the care and competence of the operator and the caution undertaken in managing the height of the cut given uneven topography and grading debris off of the shoulder area.

Clubroot Status Report

Mr. Van Beers presented his clubroot status report and provided details regarding an extremely high infestation that a crop producer had called about with concerns in his crop of clubroot resistant canola. Administration met with the producer along with Mr. Orchard with the Canola Council of Canada and Mr. Manolii with the University of Alberta. It was concurred that this field is likely a severe case of pathotype shifting. Mr. Manolii took samples for clubroot pathotyping and Mr. Orchard will request the seed company to confirm variety through varietal testing.

Mr. Van Beers reported on his attendance at the International Clubroot Workshop in August 2018 and noted that pathotype shifts are happening world-wide.

Field inspections in canola crops are ongoing into the fall. As of August 17, 2018 451 fields have been inspected, with 63 confirmed to have clubroot and 18 of those at high levels of infestation. Approximately 351 fields remain to be inspected.

Agricultural Services Department

Mr. Broadbent, Director of Agricultural Services presented the proposed 2019 Agricultural Services department budget:

- Consideration was given to ensure that priorities align with the new strategic plan.
- No new services or staffing has been included in the proposed 2019 budget. The
 operating budget reflects maintenance of current programs and services with
 existing staff.
- New initiatives open for consideration that could affect the proposed operating budget for 2019 or in upcoming years include the Rural Roadside Mowing program and an Agricultural Land Use Planning Specialist:
- No major adjustments to revenue proposed, including the Agricultural Service Board grant, shared employee agreements, and the Fees and Charges schedule.
- Function 63-00: Increase grant to organizations from \$9500 to \$22,500 to provide \$10,000 in sponsorship of the Alberta Farm Fresh Producers Association conference; increase ASB Bursaries to five from two \$1000 bursaries.
- Function 63-01: No net changes, adjustments to cost increases equals decreases.
- Function 63-02: No net changes, pending review of fuel costs. Additional operating costs of \$170,000 for staff, fuel, and maintenance of equipment only if decision is made to full implement Rural Roadside Mowing program.
