#### **ASB Bursary Awards**

Aaron Van Beers, Manager of Agricultural Services reviewed the ASB bursary awards report background points with reference to the applications received for the 2019 Agricultural Service Board bursary awards:

- The deadline to receive applications was November 30.
- Advertising was placed in the local newspaper, on social media, the AgMatters enewsletter, and with student services at a number of Alberta colleges with agriculture specific programs.
- Four applications were received prior to the deadline, with three meeting the
  eligibility criteria for attendance in an ag-related post-secondary program although
  of those applicants one did not reside (nor do parents reside) within Leduc County
  boundaries. The fourth applicant was in a program not specifically ag-related and
  who did not meet the residency criteria for themselves nor immediate family.
- One application was received past the deadline and further, the individual did not meet the criteria of being a student currently enrolled in a post-secondary program for the 2019/2020 term. A response has been sent encouraging the applicant to re-apply for the bursary award in 2020.

#### 2020 Provincial Agricultural Service Board Conference - Resolutions

Aaron Van Beers, Manager of Agricultural Services reported that the proposed resolutions that will be presented at the 2020 Provincial ASB Conference have just been received and provided the following review of resolution topics:

- Resolution #1 Alberta Agriculture Website: Reinstate Ropin' the Web accessibility and re-introduce the General Store service, sponsored by Cypress County.
- Resolution #2 Ropin' the Web: Essentially the same content as Resolution #1, and it is likely that the two resolutions will be combined to be jointly sponsored. Sponsored by Mountain View County.
- Resolution #3 Weed and Pest Surveillance and Monitoring Technology Grant: Requesting provincial grant funding to assist municipalities manage field data by means of a developed mobile application with reference to provincial surveillance programs performed by municipalities. Sponsored by Woodlands County.
- Resolution #4 Clubroot Pathotype Testing: Commit to long term funding for the Clubroot Surveillance and Pathotype Monitoring conducted by the University of



Alberta to permit continuation of the unbiased, world recognized testing that is performed by the U of A Clubroot Research Team. Sponsored by Big Lakes County.

- Resolution #5 Education Campaign for Cleanliness of Equipment for Industry Sectors -Targeting dealerships of farm + construction equipment to promote management of weeds and crop diseases. Sponsored by Cypress County.
- Resolution #6 AFSC Assist in Preventing the Spread of Regulated Crop Pests:
   Urging Minister of Alberta Agriculture + Forestry to enter into an agreement with
   AFSC to assist in regulating the spread of pests whereby AFSC would decline
   insuring canola crops planted back to back, and impose a premium on cropland
   planted in contradiction to the Province's Clubroot Management Plan. Sponsored
   by Kneehill County.
- Resolution #7 Beehive Depredation: Include beehives destroyed by bears in the Wildlife Predator Compensation Program. Sponsored by Northern Sunrise County.
- Resolution #8 Agricultural Related Lease Dispositions: Transfer of the management to the Ministry of Agriculture and Forestry to streamline/expedite the disposition process. Sponsored by Big Lakes County.
- Resolution #9 Emergency Livestock Removal: Provide necessary resources to create designated sites and a process for the evacuation of livestock under the Emergency Management Act. Sponsored by County of Northern Lights.
- Resolution #10 Mandatory Agriculture Education in the Classroom: That mandatory agriculture education be implemented in the school curriculum in Alberta. Sponsored by Lac La Biche County.
- Resolution #11 Reinstate a Shelterbelt Program Alberta Agriculture + Forestry implement a shelterbelt program. Sponsored by Brazeau County.
- Resolution #12 Compensation to Producers on Denied Land Access to Hunters:
   Do not pay compensation to producers who experience wildlife damage where land access to hunters is denied. Sponsored by District of Willow Creek No. 26.
- Resolution #13 Proposed Amendments to Part XV of the Federal Health of Animals Regulations: -That CFIA postpone amendments to requirements to the reporting of livestock movements until such time as the identified data requirements can be accurately collected by livestock producers and farm operators. Sponsored by Municipal District of Pincher Creek.
- Resolution #14 Canadian Product and Canadian Made: Amend guidelines for Made in Canada, Product of Canada claims to not include pure products such as honey as currently raw products such as honey may be mixed with up to 30% of imported honey. Sponsored by Northern Sunrise County.
