MINUTES OF LEDUC COUNTY, AGRICULTURAL SERVICE BOARD MEETING HELD ON SEPTEMBER 9, 2019 IN THE COUNCIL CHAMBERS OF THE COUNTY CENTRE, NISKU, ALBERTA

Order and Roll Call

The Agricultural Service Board meeting was called to order at 9:00 a.m., Monday, September 9, 2019 by Chair Glenn Belozer with Board Members Kelly-Lynn Lewis, Ray Scobie, Rick Smith, Larry Wanchuk and Public Members-At-Large Roy Eckert and Russell Kushinski present. Board Member Tanni Doblanko was unable to attend for personal reasons, and Board Member Kelly Vandenberghe was absent due to a personal commitment.

Public Presentation

Mr. John Mahon, Leduc County resident addressed the Agricultural Service Board with his concerns regarding beaver activity and flooding:

- Relating concerns on behalf of himself and neighbour, Mr. Renneberg, who has cropland adjacent to his property.
- Reports flooding on cropland due to blockage at a culvert on Airport Road and that
 he and his neighbour have been endeavouring to clean it out; but beaver activity
 blocks it up again quickly.
- Related that Mr. Renneberg has received promises from Leduc County staff that the road culvert will be cleared out, but so far that has not happened.
- Would like to have culvert plunged out and beaver screens installed.
- Mr. Mahon distributed a letter prepared by Mr. Renneberg.

Mr. Broadbent, Director of Agricultural Services provided background information on behalf of administration:

- Provided an aerial map overview of the Clearwater Creek drainage basin area, and the local movement of water northward through a centerline welvert situated at Airport Road.
- Commented on the history with seasonal flooding concerns around the Lake No. 10 wetland area on either side of Range Road 234 south of Airport Road.
- A landowner on the north side of Airport Road has, historically, been reluctant to consent to Leduc County access to manage dams and beavers on his property. However, he was agreeable to permit foot access to Leduc County workers to hand pull dams after meeting with Mr. Broadbent to discuss the flooding threat to the road.
- Public Works road operations staff has communicated that arrangements are being made to situate a track hoe on Airport Road to plunge out the culvert.

Mr. Van Beers, Agricultural Foreman provided additional comments:

- No beaver activity has been noted on the north side of Airport Road and dams that have been hand pulled have resulted in the flow of water with no new beaver rebuilds.
- There may be some beaver activity on Mr. Mahon's property as well as an accumulation of vegetation and deadfall debris as water moves downstream.

Agricultural Services Department Activity Report

Agricultural Services administration staff provided additional information on reporting within the Agricultural Services Department activity report:

- Pest Control Officer beaver control activities have been focused on County road infrastructure; seasonal staff have worked at hand pulling dams repeatedly at various locations to facilitate movement of water in drainages.
- 632 canola fields inspected for the presence of clubroot to date, 128 confirmed to have clubroot, secondary surveys will be conducted on 24 of those due to severity and suspected pathotypes shift.
- In spite of wet conditions, the mowing program has progressed well through the season.
- Some funding is still available through ALUS for new projects.
- Final weed inspections are taking place and Weed Inspectors are urging late season control on Canada Thistle and CommonTansy.
- Additional conditions were added to some of the weed notices issued due to the
 extremely wet conditions and in acknowledgment that fields might have been
 inaccessible during the control period.

- Due to rain and wind, it has been an extremely challenging season for spraying work for the various programs. As seasonal staff have completed their seasonal employment terms, Mr. deMilliano, Agricultural Foreman, will continue to work at completing spraying for as long as the growing season permits.
- Fenceline spraying program Adjustments will have to be made to spray from the roadside as accessing private lands from the crop side, as is usual practice, will not be possible in most situations due to wet conditions.
- PW-AG Operations Cooperation Shared mapping has supported planning for field operations to coordinate effective control in brushing areas.
- In response to a Division One resident who expressed concern about biosolids applications on cropland in her neighbourhood, administration was able to talk to the Nutri-Gold program foreman on the application site. The foreman provided detailed information about pre-site assessments, soil testing through proposed application field space, 30 hour time limit on incorporation and all aspects of application site and activities are fully vetted through Alberta Environment.

- No discussions on funding yet beyond CAP cost-share which has been reduced to 50% from 75%
- Strategy development African Swine flu in the event of an outbreak and the potential consequences of loss of slaughter facilities

Moisture and Precipitation Update

Mr. Van Beers, Agricultural Foreman provided data on precipitation and soil moisture level information compiled by Alberta Agriculture + Forestry. Lac Ste. Anne has just recently made a declaration of a state of agricultural disaster based on the severe and widespread flooding of cropland experienced throughout that area.

Board Member comments were heard about conditions being experienced by producers and how that bears on the current calendar date in terms of potential recovery and losses already experienced.

Alberta Care Conference – Board Member Verbal Report

Chair Belozer provided comments on a presentation about a CleanFarms pilot "Alberta Ag-Plastic" for the recycling of agricultural plastics at the recent Alberta Care Conference:

- Net wrap is comprised of multiple materials and is not suitable for recycling under this program, as well, silage wrap will not be included initially and another end use is being sought.
- 5 year program scheduled to start up in October 2019
- Grain bags and twine will be collected for recycling at 20 designated pilot drop off sites with five more sites to be designated in 2020
- The closest site currently designated is Riley
- Twine to be recycled for processing in to car bumpers (in Mexico via US). Polypropylene bumpers are a recyclable product.
- Grain bags will be processed in to garbage bags.
