

Agricultural Services department activity report

040-2020 Board member Kushinski – that the Agricultural Service Board receive as information the Agricultural Services department activity report for the July through August 2020 period.

2020 ASB resolutions report card

Manager of Agricultural Services Aaron Van Beers provided a staff report reviewing the 2020 ASB Resolution responses and the Provincial ASB Committee report card grading those responses:

#1-20: Ropin the Web – Accept in Principle; administration concurs with grade

#2-20: Weed and Pest Surveillance and Monitoring Technology Grant – Incomplete; administration concurs with grade

- #3-20: Clubroot Pathotype Testing Unsatisfactory; administration concurs with grade. Additional comments regarding potential to utilize some portion of the canola grower checkoff to support funding.
- #4-20: Education campaign for cleanliness of equipment for industry sectors Unsatisfactory; administration concurs with grade. Additional comments that response did not address the intent of the whole that education/expectation of equipment sanitizing management should not be limited to industry sector or be seen to shift responsibility solely to industry sector.
- #5-20: AFSC Assist in preventing the spread of regulated crop pests Unsatisfactory; administration concurs with grade. Additional comments: at present, Warburg seed cleaning plant has a policy to not accept fusarium infected seed for cleaning. Administration is aware that there are municipalities that have passed a bylaw regarding control of fusarium and is watching those developments closely.
- #6-20: Beehive depredation Accept in principle; administration concurs with grade
- #7-20: Agricultural related lease dispositions Accept in Principle; administration concurs with grade
- #8-20: Emergency livestock removal Accept in principle; administration concurs with grade

Public member-at-large Eckert

Board member Eckert entered the council chamber at 9:47 a.m.

- #9-20: Mandatory agriculture education in the classroom Unsatisfactory; administration concurs with grade. Additional comment that directing resolution to school trustees may find a more receptive body.
- #10-20: Reinstate a shelterbelt program Accept in principle; administration concurs with grade
- #11-20: Resolution was defeated at conference and not brought forward (provided for numbering continuity)
- #12-20: Proposed amendments to federal health of animals regulation Accept in Principle; administration concurs with grade
- #13-20: Canadian product and Canadian made Incomplete; administration concurs with grade.

 Additional comments that resolution misses the mark, that this is a food labelling issue.
- E1-20, E2-20, E3-20 Business risk management programs, including AgriRecovery, Agri-invest, Agri-Stability Unsatisfactory; administration concurs with grades on each of these emergent resolutions. Additional comments: municipality specific impacts on local producers vastly different from one area of Alberta to another, trade partner references to specific countries is sensitive to changing politics.

Board member Smith
