

Public presentation - Tri-County Ag Business project update

Serecon consultant, Darren Haarsma joined the meeting to provide a presentation with an update on the Tri-County Ag Business study project in person (Bob Burden, senior director, Serecon joined the meeting remotely).

Tri-County Agriculture Business Study final report presentation highlights:

171B.

- Project path interviews with industry leaders to identify macro drivers and compared to region profile; interviews with region agribusiness and primary producers to identify specific business opportunities and principles for successful agrifood economic development; interviews with tricounty mayors to refine collaboration recommendations.
- Examined nine agribusiness opportunities to assess strengths of market opportunities and tri-county success factors i) agrifood technology ii) irrigation iii) vertical farming and aquaponics iv) food processing v) protein fractionation vi) meat processing vii) hemp fibre viii) oat processing ix) automated grocery fulfillment centres
- Three recommendations developed out of findings: 1. principles of effective agrifood economic development; 2. structured agrifood economic development strategy; 3. collaborate sub-regionally on projects with specified goals and boundaries
- Collaboration suggestions: Agrifood economic development committee and tri-county agrifood database development
- Conclusions: A framework has been developed that is both specific and adaptive, prioritizing existing businesses and providing insights that can be applied across all opportunities.

Clubroot - Inspections review

Manager of Agricultural Services Aaron Van Beers provided a staff report reviewing the outcomes of the 2020 crop inspections for the presence of clubroot in canola. While more clubroot was identified (percentage of fields infected), it was not as much as was expected given the wet field conditions. Van Beers commented that it is likely that the annual clubroot information meeting will have to be cancelled in light of COVID limits on gathering and other options are being considered for distributing information and collecting producer feedback.

Culvert/beaver debris concern

Board member Lewis provided a verbal report on a letter received jointly from two property owners requesting placement of beaver screens on a centerline culvert through Airport road east of Range Road 234. Photos of various beaver screen configurations were also provided.

Manager of Agricultural Services Aaron Van Beers commented that Road Operations staff undertake periodic clean out of mud and debris accumulated in the culvert and that this is an ongoing maintenance task. The current culvert end is cut diagonally and beveled and would require a specific type of screen construction to be effective over the long term as well as lending itself to regular cleaning.

061-2020 Board member Lewis – that with reference to beaver screens or gates to protect road culverts from beaver damming activities:

- 1) staff investigate various options for beaver screens or gates and the relative costs and maintenance requirements associated with those options, and further that
- staff undertake an inventory of other road culverts of this approximate size that are currently subject to beaver caused obstructions.
