## 5. General Business

#### Organizational Meeting – Election 5.1

- Dean led the committee in the election of Chairman.
- Representative Rick Smith nominated Representative Raymond.
- No other nominations were brought forward.
- Representative Raymond accepted the nomination and was acclaimed Chair of the FCSS Advisory Committee.

- Representative Raymond requested nominations for the position of Vice-Chair.
- Representative Rick Smith nominated Representative Scobie.
- No other nominations were brought forward.
- Representative Scobie accepted the nomination and was acclaimed Vice-Chair of the FCSS Advisory Committee.

#### 5.2 **Multi-Municipal Agreement overview**

- The Multi-Municipal Agreement establishes the four municipalities that work within the agreement.
- Dean and Sara met with the Province to better understand the expectations for funding and funding distribution.
- The staffing of the FCSS offices in each municipality is unique.
- Information is collected from each municipality by Leduc County FCSS. From the information collected, Leduc County FCSS provides reports to the Province.
- There will be a review of the funding and reporting process.

## 6. Information Items

#### 6.1 **Home Support program changes**

Sara reviewed the changes with the committee members.

- The Outreach Support/Home Help program currently has 80 clients and 14 workers.
- Serving Hands Senior Care (Serving Hands) has signed a one-year contract to provide housekeeping services to eligible seniors and adults with disabilities.
- Most of the providers have chosen to discontinue with the program and have either offered their services privately or not at all.
- Clients who wish to receive services through Serving Hands at a subsidized rate are referred to Serving Hands.
- The transition deadline is March 1, 2019.
- There may possibly be some complaints as change is hard and not much notice was given.
- Having Serving Hands take over the Outreach/Home Help services will allow more time for to assist seniors who need additional support.

Discussion ensued.

### 6.2 Christmas Elves program

Sara provided an update on the Regional Christmas Elves & Santa's Helpers partnership to the committee.

- The Santa's Helpers board of directors requested a meeting with all of the Christmas Elves programs throughout Leduc County, to identify challenges and new ways of working together.
- There are seven programs in the region.
- There are program inconsistencies between communities.
- The committee meets two times a year.

Discussion ensued.

#### 6.3 **FCSS Department Annual Report**

Sara provided the annual overview of the following programs:

### Home Alone

- There were 10 Home Alone workshop sessions that were held in Calmar, Thorsby, Warburg and Nisku.
- New Sarepta's grade five teacher provides the material to her students.

### Golden Rules

- There were two workshop sessions that were held in Thorsby and New Sarepta.
- Seniors are invited to share stories about growing up in their generation, to children in the school or in the community.
- Seniors who participated in the workshop said that they felt a stronger sense of belonging in the community.

## Community Volunteer Income Tax Program

- 111 tax returns were completed, netting more that \$393K in refunds and access to government assistance.
- Regionally, 347 returns were completed with over \$1 million in refunds and subsidies.
- Statistics are now being collected differently to showcase the impact this service has for the community.

## **Counselling Subsidy**

- Counselling subsidies of over \$15,000 were provided to support 33 individuals, 4 couples and 6 families using a total of 188 counselling sessions.
- Access to counselling subsidies are down from previous years, but this may be due to the amount of workshops being run.

# Family Support & Youth Services

- This program served 30 one-on-one clients.
- There were two Grief Support groups for 15 individuals in partnership with Karunia Counselling.

### Seniors Services

- A total of 85 households were provided housekeeping services.
- A total of \$20,000 in subsidies were provided to assist with the cost of the housekeeping services.

Carol Tabone reviewed statistic totals for the entire region for the following programs:

- Leduc Regional Parent Link Centre
- Family Connections Home Visitation
- Early Childhood Resource program
- Bridges FASD Mentor program

Sara provided the annual overview for the County Connect program.

 County Connect provided \$17,677.34 in funding to residents who were homeless or living at imminent risk of homelessness.

Sara provided information on the upcoming Home Alone Workshops.

- County residents are given priority for workshop registration.
