## Nisku Recreation Centre Future Direction (Review of County Council Decision)

A copy of the Recommendation to County Council regarding the Nisku Recreation Centre Future Direction was distributed for information.

Dean Ohnysty gave a historical overview of the Nisku Recreation Centre. Although there have been many changes and improvements to the facility and operations, the adjustments have resulted in an improved facility but come with a cost. A cost that has not been recovered through revenues. The recommendation to County Council is to discontinue the current services provided by the Nisku Recreation Centre and review alternate options and a phase out plan.

### Genesee

The Genesee Park Group Campground has been completed. The soft opening is for the July long weekend with a grand opening event on July 11, 2019 from 5 to 7 pm.

The campground will feature nine defined sites with a firepit at each site, a picnic shelter, a central group firepit, double vault toilets, walking path adjacent to the Genesee Heritage Park which offers a stocked fishing pond and more.
