NEW BUSINESS

Cultural Grants Review

A copy of Arts and Culture Grant Funding Application Summary 2019 was distributed for review. Andrea Oneski reviewed the criteria for funding and the timeline/process. For 2019, \$15,000 grant funding is available with a maximum of \$1,500 for project funding and a maximum of \$250 for operating. Recommendations for funding will go to Leduc County Council on March 26, 2019 for formal approval and adoption.

The grant applications were reviewed and amounts were awarded to successful applicants for a total of \$11,650. It was recommended that the remaining amount of \$3,350 be held in reserve to be allocated at a later date.

Cost Share Capital Summaries

A copy of the 2019 Recreation Cost Share Capital Plan Recommendation was distributed for information.

Leduc County supports the services of recreation and libraries across the region through the Cost Share Agreements. This program supports annual operations as well as facility upgrades and capital projects. The following is a list of projects that Leduc County will support in 2019 for a total of approximately \$366,000.

Beaumont: Ken Nichol Arena Roofing Phase 1 (\$14,346) and athletic fields (\$24,583). Calmar: Arena improvements (\$83,073) and athletic field development (\$71,205).

Thorsby: Complex improvements (\$34,174).

Warburg: Library washroom improvements (\$3,700).

Leduc: Various projects (134,739).

Healthy Communities Initiative

On behalf of the Hamlet of New Sarepta, Leduc County is one of the regions selected from 60 rural Alberta communities to take part in the three year Alberta Healthy Communities (AHC) Initiative.

The AHC Initiative will provide New Sarepta the opportunity to create or enhance local partnerships to address community wellness. The vision of this initiative is to create a healthier, more engaged community. The AHC provides a platform for community-centered, evidence-based action using local community data, thereby developing initiatives tailored to New Sarepta's unique assets and opportunities. Along with resources and facilitators, this initiative comes with a \$20,000 grant to be used for community initiatives that are identified through the community engagement process.

The Town of Thorsby has also been awarded an AHC Initiative grant.

Winter Try It Festival Update

The Wizard Lake Watershed Lake Stewardship Association and Leduc County hosted the "Winter Try It Festival" which was held on Saturday February 16, 2019 from 11:00 am to 3:00 pm at Jubilee Park Campground day-use area.

The festival was well attended with 190 participants even thought it was a very cold day. Over 20 volunteers helped out. All of the activities were free. A shuttle vehicle was donated by Enterprise which shuttled participants from overflow parking to the day-use area. This event will be hosted for two more years as a result of the grant the Wizard Lake Watershed Lake Stewardship Association received through the Alberta Summer Games Legacy fund.

Vistas Parks Strategy

A copy of the Vistas Parks Strategy Recommendation was distributed for information. County Council approved the Vistas Parks Strategy at their February 26, 2019 Regular Council Meeting.

Throughout 2018, Leduc County worked with IBI Consulting to prepare a parks visioning strategy for the Vistas community. This document addresses the urban growth area adjacent to the City of Beaumont. This document will now be used as a guide and common vision to future Leduc County community developments. Developers/land owners will reference the strategy in preparing their outline plans, subdivisions and developments. The community can reference this document as a way to understand the future goals and direction of development in the Vistas area. The full document is available on the Leduc County website.
