### Regional tourism

Dean Ohnysty advises that the Leduc Chamber received a grant of \$50,000 to develop regional tourism in 2020. Funds were utilized to promote tourism through the website by developing an interactive map filtered by categories, social media marketing, blogging and hosting events. The Leduc Chamber has requested an additional \$30,000 in 2021.

Community grants process changes

Dean Ohnysty provided an update of Council decision to amend the community grants process. Due to the pandemic the annual spring grant process was delayed. Grant applications will be considered by Council this fall for 2021 project and events. Community grants will now be received, reviewed and awarded each fall for the following year.

Regional reports

Verbal reports were given for each region.

Elizabeth Leeb – that the annual New Sarepta demolition derby will take place the weekend of September 12 and 13. The AG society will live stream the event. Minor hockey will be hosting a 50/50 draw.

Tracy Musson – The Thorsby library was previously open only one day a week, but has recently been extended to two days a week. Playschool operations will resume completely by end of September. Pickle ball has resumed outside of the Thorsby complex. Thorsby trails are being repaired and have been expanding in the South East corner. A local business hosted a 45 car show fundraiser raising \$3000 for Family and Community Support Services. Halloween fundraiser to be hosted at the Thorsby hotel. Lions Park considering hosting haunted trails dependent on weather.

Mary Ann MacDonald – the Beaumont Blues festival sold out even at a reduced ticket capacity due to COVID-19 restrictions. AG Society is considering hosting a fall parade.

Ron Patrick – due to COVID-19 restrictions, Devon residents have been more inclined to utilize the River Valley trails and Parks. Commended the Leduc County Parks and Recreation department on its progression towards securing the land on the North Saskatchewan River as well as its partnership with the Beaumont Recreation Center.
