#### **New Business**

#### **Arts and Cultural Grants Review**

A copy of Arts and Culture Grant Funding Application Summary 2020 was distributed for review. Andrea Oneski reviewed the criteria for funding and the timeline/process. A copy of the eligibility assessment tool used to rank the applications was also distributed. For 2020, \$15,000 grant funding is available with a maximum of \$1,500 for event/project funding and a maximum of \$250 for operating. The recommendation for funding will go to Leduc County Council on March 24, 2020 for formal approval and adoption.

A total of \$47,870 in application requests were received; therefore, not all funding requests will be fulfilled. The grant applications were reviewed and amounts were awarded to successful applicants.
