Alberta Justice Bulletin #19-2020 - Regulation Amendments to Eliminate Permits

Officer Nelson went through the Alberta Justice Bulletin #19-2020 - Regulation Amendments to Eliminate Permits with Committee Members. Clarence indicated that certain permits will no longer be needed as the requirements will be in regulations instead.

There was discussion around the change to legal weights pertaining to wide case single tires, steer axles, Transport Association of Canada (TAC) allowable weights for tridem axles and vehicles exceeding 53,500 kgs GVW.

Municipalities will still be able to put on road bans. However, if our municipality feels our roads are not ready for this change in leal weights, we can still set our own maximum legal weights locally. If we do this, it needs to be treated as a road ban with the same amount of signage on each local road.

Des indicated he is concerned about single-wide base tires; depends what variety they use; rutting and damage to road could be worse. Can see accellerated degration to roads in Nisku.

Fire-Emergency Services

Sub-Regional Emergency Management Agency Update

Ivana Irwin, Deputy Fire Chief reported that Phase 1 of the Sub-Regional Emergency Management Agency project has been completed by Behr Integrated Solutions. Phase 1 included research and information gathering from participating municipalities, namely: Leduc County, City of Leduc, City of Beaumont, Town of Calmar, Town of Thorsby and Village of Warburg.

The municipalities participated in a workshop held by Behr Ingrated Solutions and then there was followup interviews with designated members of each municipality.

Behr Integrated Solutions has moved to Phase 2 of their work which is the development of draft agreements, bylaws and emergency response plans with the tentative completion by October 30, 2020.

East District Fire Station Update

Keven Lefebvre Fire Chief reported that Scott Builders have commenced groundwork on the East District Fire Station. Keven went through the proposed plans with Committee Members. Starting this Friday, there will be meetings with Scott Builders every second week to discuss progress, issues, etc.
