Messrs. Chance and Neil Matter, Matter Water Service

Mr. Chance Matter and Mr. Neil Matter entered Council Chamber at 1:49 pm

Mr. Chance Matter presented that:

- They are a long standing family owned business in the County
- They are being undercut by Sherwood Park and City rates at \$2.38/m³
- Is requesting a lower rate (volume rate discount)
- Sherwood Park haulers not buying the same volumes, not paying taxes, and running in subdivisions without permits on triaxle permits
- Requested what rates are charged for a warehouse in Nisku (Dean indicated \$3.40/m³) wondering why there is a difference.
- Clarification requested by Mayor Doblanko, about what volume might be considered to be the "volume", who gets it, and where the difference would be made up.
- Matter uses between 600-700 m³ per month. Average home hauls 10 m³ per month.
- Mr. Matter indicated that they are one of the heaviest users in the park for potable water, Patrick's has made a deal at Edmonton Airports,
- City of Leduc is open to making a deal matching Sherwood Parks price

Bulk Water Request for Commercial Rate
