Order and Roll Call

Village of Warburg Cost Share

City of Beaumont Border Roads Agricultural Access

Historically agricultural producers in the area have been provided with a letter from the City of Beaumont to provide road ban exemption for the 75% ban to access Range Road 241. Leduc County received a concern from an agricultural producer that an exemption to the road bans would no longer be provided. Administration contact the City of Beaumont to try to assist in the request and City stated they would contact the producer regarding this consideration. Discussing this with the producer later, the City of Beaumont had indicated that a bond would be required in order to provide this exemption, otherwise suggested an alternate route that would be an additional 12 miles.

Discussion ensued, that Leduc County should not be interfering with another municipality's method of protecting their roads.

If Leduc County makes that change, then it would not be fair to others within the municipality that are affected by the road bans when they are hauling on the Leduc County roadways for agriculture or sewage disposal etc.

Leduc County is unaware of any other similar requests at this time.

Deer Crossing/Range Road 240 Paving Request Re: 19-019

Councilor Lewis received a letter from the developer of Deer Crossing Estates that he is willing to contribute \$100,000 to the paving of Range Road 240A, if the project is completed in 2020. The tax base is high from houses being built in this subdivision.

As of December 2018, there are 12 developed lots, with 23 more available to be developed.

Discussion ensued that it is an opportunity for Council to invest in the area, as a result Leduc County will benefit from the taxes received form these homes, and the County would benefit by receiving these funds.

If the entire tax levy is put towards the roadway (at full build out), recovery would be between 2022-2030.

The estimated cost to surface the roadway is \$648,000.00 for surfacing of 1.2 kilometres of roadway.

Leduc County has contributed in the past knowing that the payback will be received eventually, for example, the Amazon warehouse development.

This could be an opportunity to mitigate some loss of tax base from annexation, by allowing the development of some homes with high assessed value as well as reduce the overall cost of the roadway through the developer contribution.
