Destiny BioScience - Access off Spine Road

Currently has access to property from 9th Avenue. Property has full fencing and sliding gates. Has requested a permit from Planning & Development to build an access to the property from 9th Street, also known as Nisku Spine Road. This access would accommodate a circulation for truck access. As well, this access would be a right in and right out, with no left turns.

Public Works Engineering department would like this request denied as the Nisku Spine Road is designated as an arterial roadway that is to have no direct access from properties and limited intersections. Public Works Engineering has also stated that previous similar applications have been denied for this reason.

New Sarepta Wastewater Reuse Re: 07-19

Mr. Peter Christou presented the following:

Swirltex builds custom wastewater treatment systems for a wide range of applications. This technology allows for the treatment of wastewater types that would otherwise not be re-usable.



The treated water could then be used for businesses that consume large volumes of water such as car washes, recycling plants, and other agricultural and industrial applications.

Mr. Christou is reaching out to rural governments with a business plan to lengthen the life and usage of lagoons as well as discuss the environmental benefits of using the Swirltex system.
