A BYLAW ESTABLISHING 2023 FEES AND CHARGES FOR SERVICES PROVIDED BY LEDUC COUNTY AND THAT BYLAW NO. 21-22 BE REPEALED.

WHEREAS

pursuant to the Municipal Government Act, being Chapter M-26, Revised Statutes of Alberta, 2000, and amendments thereto, the County is requested to provide various services and/or to make certain information available to the public;

in accordance with Section 8 of the Municipal Government Act, and Section 93 of the Freedom of Information and Protection of Privacy Act, Council may pass a bylaw establishing fees to charge for providing information and services; and

Council is desirous of establishing the Fees & Charges schedule effective on the date of third reading.

NOW THEREFORE


be it resolved that the Council of Leduc County, duly assembled, enacts as follows:

1. This bylaw may be cited as the "Fees and Charges Bylaw".
2. The fees and charges shall be as detailed in Schedule "A", which is attached to and forms part of this bylaw.
3. Bylaw No. 21-22 is repealed upon this bylaw coming into force.
4. This bylaw shall take effect on the date of third reading.
