

BY-LAW NO. 22-02

**A BY-LAW OF LEDUC COUNTY TO AUTHORIZE A LOCAL IMPROVEMENT TAX IN RESPECT OF LANDS BENEFITTING FROM THE INSTALLATION OF A SANITARY SEWER SYSTEM IN THE NISKU INDUSTRIAL BUSINESS PARK (THE "LOCAL IMPROVEMENT PROJECT").**

WHEREAS the Local Improvement Project has been authorized by the municipal Council of the Leduc County as a local improvement project as described in Schedule "A" attached hereto and forming part of this By-Law;

AND WHEREAS the lands that will benefit from the Local Improvement Project are described in Schedule "B" attached hereto and forming part of this By-Law and shall bear the local improvement tax imposed by this By-Law;

AND WHEREAS the persons and corporations listed in Schedule "B" and their successors in title shall pay the local improvement tax established by the By-law in equal annual installments over the period which the cost of the Local Improvement Project will be spread;

AND WHEREAS the local improvement tax is to be based on assessments prepared in accordance with Part 9 of the Municipal Government Act R.S.A. 2000, c.M-26;

AND WHEREAS the estimated cost of the Project is \$13,602,460.32.

AND WHEREAS the cost of the Local Improvement Project will be spread over TWENTY (20) years;

AND WHEREAS the total cost of the Local Improvement Project shall be paid from the local improvement tax;

THEREFORE, THE COUNCIL OF LEDUC COUNTY DULY ASSEMBLED ENACTS AS FOLLOWS:

1. A local improvement tax is hereby imposed at the rates and on the lands described in Schedule "A" attached hereto and forming part of this By-Law.
2. The local improvement tax hereby imposed shall be paid in equal payments during each year over which the cost of the Local Improvement Project will be amortized being TWENTY (20) years commencing in 2003.
3. Notwithstanding Section 2 above, the Persons liable to pay the local improvement tax will have the option of paying, in advance, their portion of the costs of the Local Improvement Project in one lump sum payment.
4. The By-Law shall take effect on the date of the final passing thereof.

## **SCHEDULE "A"**

### **By-Law No. 22-02**

The Local Improvement Project shall include the following:

The proposed local improvement consists of the installation of a sanitary sewer system within the Nisku Industrial Park. The System is proposed to include 6,700 meters of sanitary trunk lines in varying sizes, 20,700 meters of lateral sewer trunk lines in varying sizes and a sanitary sewer connection line of 150 mm to each parcel (except as noted) within the benefitting area of the local improvement. The sanitary sewer connection would not be installed for properties less than .25 acres (.101 hectares) which are considered undevelopable and those County-owned properties such as the reservoir land which will never become commercially-developed properties; however, lots within the Nisku hamlet which may be less than .25 acres but which are already developed will be provided with sanitary sewer connections.

The area of the proposed Sewer System would be the area bounded by Airport Road on the south, 9<sup>th</sup> Street on the east, 25<sup>th</sup> Avenue on the north and Highway 2 on the west. Also included would be the businesses fronting 15<sup>th</sup> Avenue and 10<sup>th</sup> Street east of 9<sup>th</sup> Street. Excluded are the lands owned by Ritchie Brothers between Sparrow Drive and Highway 2 and the properties within Alberta Legal Plan No. 0021583 (the PCL Subdivision), which is comprised of the bulk of the Northwest quarter of the 15<sup>th</sup> Section of Township 50, Range 25, West of the fourth meridian.

The attached map outlines the affected area and shows the location and size of the sewer lines proposed to be installed.

The Local Improvement Project will be constructed over a period of one to four years. Although the project may be tendered as a complete package and awarded to a single contractor, care will be taken to ensure that disruptions to the conduct of business within the Park are minimized.

#### **Identification of Affected Properties and Persons liable to pay the Local Improvement Tax**

The proposed Local Improvement Tax will be imposed on all of the parcels in the affected area (except as otherwise noted) and the registered owners of those parcels shall be liable to pay the Local Improvement Tax. Attached is a complete list of the affected properties, the persons liable to pay the Local Improvement Taxes and the amount of the tax to be imposed against each parcel. The annual payments on a 20 year amortization will be dependant upon the interest rate obtained by the County when it borrows the money to finance the Local Improvement Project. No Local Improvement Tax will be imposed on parcels of less than .25 acres (.101 hectares) which are considered undevelopable and will not benefit from the Sewer System (except those lots within Nisku hamlet noted above). Also no Local Improvement Tax will be imposed on parcels owned by the County that are not commercially developable and which will not receive any benefit from the Sewer System.

#### **Basis for Local Improvement Tax Rate**

The project will be financed entirely by a Local Improvement Tax based on the area of each parcel of land within the affected area that benefits from the Local Improvement Project. The basis for determining the amount of tax to be levied on each parcel is as follows:

There shall be a minimum connection component of \$9,300.00.

All assessable properties less than 1 acre in size shall pay only this amount.

All assessable properties measuring between 1 and 5 acres in sized shall be charged \$9,300.00 plus \$8,600.00 times the area (in acres) greater than 1 acre.

e.g. A property 2.46 acres in size would pay  
 $\$9,300.00 + \$8,600.00 \times (2.46 - 1.00) = \$21,856.00$ .

All assessable properties measuring between 5 and 10 acres would pay \$43,700.00 (\$9,300.00 + 4 x \$8,600.00) plus \$7,900.00 times the area in acres greater than 5 acres.

e.g. A property 8.58 acres in size would pay  
 $\$43,700.00 + \$7,900.00 \times (8.58 - 5.00) = \$71,982.00$ .

All assessable properties measuring between 10 and 100 acres would pay \$83,200.00 (\$43,700.00 + 5 x \$7,900.00) plus \$6,000.00 times the area in acres greater than 10 acres.

e.g. A property 25.63 acres in size would pay  
 $\$83,200.00 + \$6,000.00 \times (25.63 - 10) = \$176,980.00.$

There are no properties larger than 100 acres in the affected area.

### **Estimated Cost of Local Improvement**

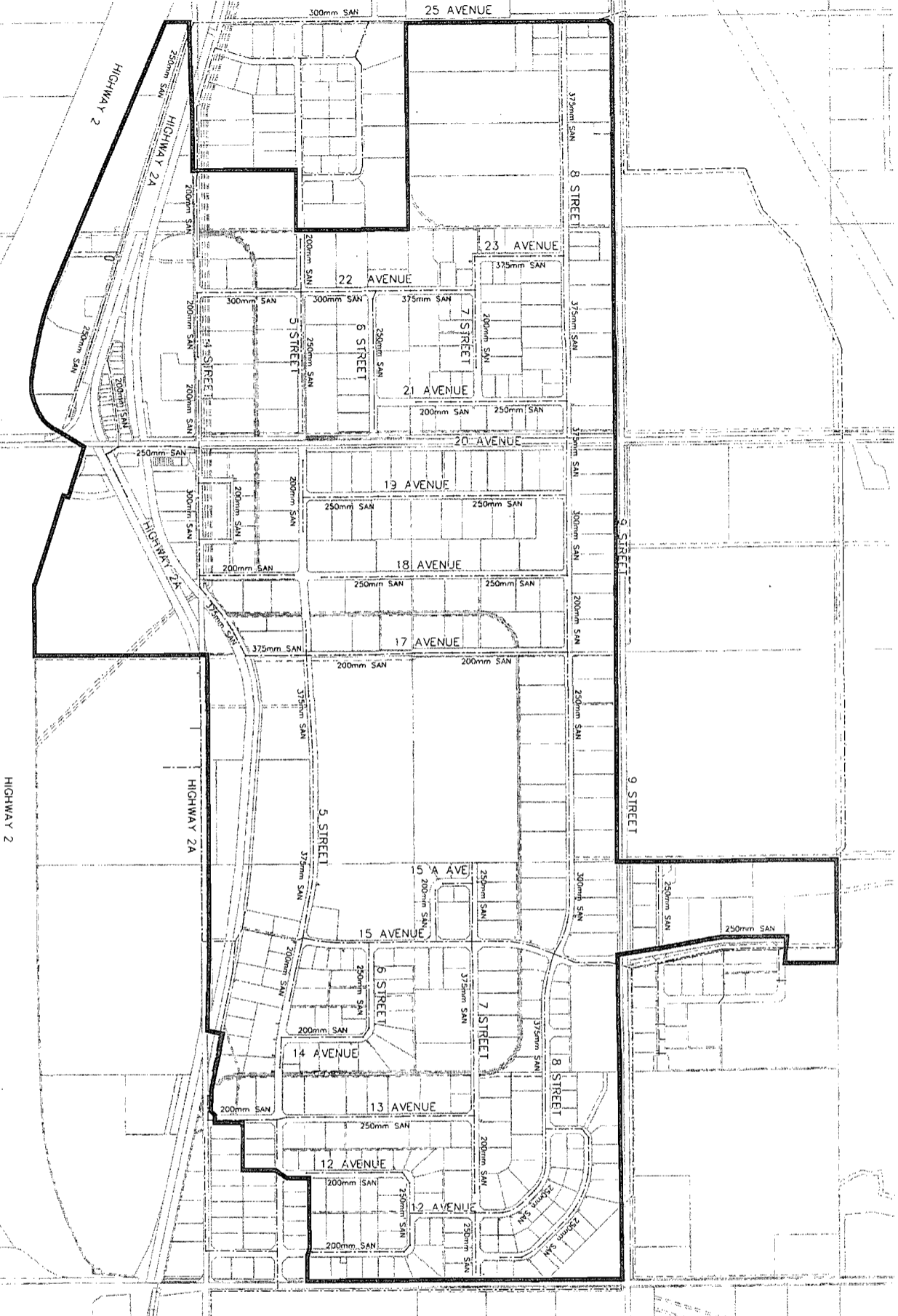
The total estimated cost of the Sanitary Sewer System is estimated to be \$13,602,460.32.

### **Period over which the Cost will be Spread**

Property owners will be given an option to pay their portion of the improvement costs in advance or to repay over a twenty-year period in annual installments.
